

RULES FOR MUD VOLLEYBALL TOURNAMENT FOR EPILEPSY

- 1. Knowing when you play is <u>your</u> responsibility. A five (5) minute grace period will be allowed for teams to show on the court after the scheduled starting time. After that, the tardy team will be assessed a point a minute. At 7-0, the game is forfeited. ONLY a Captain or a Team Representative can check the bracket boards at any one time to help alleviate congestion around the bracket boards.
- 2. Each match consists of a game to 15 points and the winner must win by a margin of two (2) points. No game may exceed the time limit of 30 minutes.
- 3. GO BAREFOOT AT YOUR OWN RISK!!!
- 4. Only 6 players on the court at a time and 2 must be female.
- 5. Switch sides when the total combined score equals 10 and every multiple of 10 thereafter or by a mutually accepted standard among both Team Captains.
- 6. Prior to serve, the ball MAY NOT be loaded with mud.
- 7. Three hits are allowed per side. A player may not hit the ball twice in succession. A block at the net is not considered a hit.
- 8. Blocking or spiking serves at the net IS NOT allowed.
- 9. Only front line players may spike at the net. Back line players must remain back line players throughout the point.
- 10. NEW: Captains representing losing teams must stay and officiate the next match on the same court. Failure to do so may result in disqualification.
- 11. Questions about rules, etc., should be addressed immediately. ONLY Team Captains may address referees or tournament officials regarding problems. Protests after a completed game are not allowed.
- 12. PROFANE LANGUAGE and VERBAL ABUSE OF REFEREES AND OTHER TOURNAMENT PERSONNEL IS PROHIBITED! After an initial warning, penalty points will be assessed and, if the problem persists, disqualification from the tournament will follow. Let's have fun, but please watch the language and respect others.
- 13. Fighting between teams WILL NOT BE ALLOWED. Team Captains are responsible for team members, and entire team will be disqualified if fighting continues and Team Captain cannot control members. Teams must also control their own spectators.
- 14. We reserve the right to make changes to ensure a smooth running tournament.
- 15. No one under 18 years of age is allowed to play, according to our insurance company.
